I. Call to Order and Introductions

II. Approve Prior Meeting Minutes – Fall 2024 minutes approved

III. Review Committee Goals:

- a. Keep the general membership and executive committee informed and educated of current and pending legislative action
- b. Maintain SAGES involvement, participation, and representation in national and state legislative functions involving health care related issues
- c. Continue to participate and pursue appropriate CPT coding for our membership with representation and communication with the RUC
- d. Enlighten and educate the press, employers, and legislative bodies about MIS options for patients
- e. Enlighten and educate patients and the public of their minimally invasive options if they are to undergo surgery.

IV. Hot Topics (Update from Rob)

- Discussed AHP/Hot Topics group pursuing a SAGES statement on the dismantling of healthcare, defunding the NIH, and what SAGES is doing behind the scenes, one that the majority of membership would support.
- Rob's video booth in Long Beach for members to create short patent-focused videos advocating for a range of issues, including Medicare and how decreased funding will affect patient care.

V. Surgical Coalition Report (Update from Ross):

- Ongoing focus on Medicare reform and reducing continued pay cuts
- Consensus to keep \$20k in the AHP budget, with increased push to get summary reports from the coalition and ensure that SAGES isn't missing any opportunities
- Another ongoing reminder about the importance of joining the AMA so that SAGES can retain representation and have a voice. System continues to need overhaul with all surgeons being united, educated and more engaged.

VI. CPT/RUC (update from Kevin and Ketan):

- Boston Scientific code cat 1 approved with no society sponsor. CMS can still modify 90day global procedure.
- Series of 9 diaphragmatic codes for slated for June (not for implementation until 2027)
- New LINX (43821) code change
