Discussion on how and when to advertise for our next 2026 US SAGES Fellow. Start date of July 1, 2026.

In the past we started in October the year before before start date, with application deadline of November the year before start date. Feedback in the past has been to start advertising much earlier. For comparison ACS advertises in July of the year before start date.

Modes of Advertising in the past have been through membership emails, social media, APDS listserve to PD's, and on SAGES Stories. It has been suggested for current fellows to create a testimonial video to help get more of an idea of what position entails and expectations of role.

Dr. Ivy Haskins suggested reaching out to Dr. Keven ElHayek and Dr. Jennie Shao who create SAGES Podcasts. This could be a good one to have a podcast about fellow position with Guidelines. Ideally work on in the summer so completed in the Fall in time for application/advertising of position. Members are also encouraged to to spread through word of mouth and let residents and program directors know this opportunity is approaching and to forward application once it opens.

We currently have had a change in our Methodologist position. Our new methodologist is Dr. Ivan Florez. He is a pediatrician in Columbia University who works with EAS and has completed lots of academic work. Sarah will need to make sure to have him sign the MOU and get him stated to submit invoices monthly.

Update on SAGES Manual – Consulting Primary Care Physician/Pediatrician. All chapters submitted. Editors have reviewed. Manual should be published soon, and will be posted on social media once it is published.

Elisa gave a review of task force and what steps are taken to train trainees on full text review and abstraction, which starts after ABSITE. New group of trainees are currently being trained. A link to the training curriculum was provided on shared slides, which lives on OWLS.

Remote and Rural Health Surgery

Dr. Calabrese gave an update. This is currently on hold; but it is two fold. One part looking at how to better support role surgeons and what resources are needed as well as what factors provide retention. The second half is economic analysis; but for the second half we are currently trying to secure funding. This is a project that we share the work on with Australia. Telemontoring has been decided on vs. Telesurgery. This was decided to focus on surgeons that feel more isolated to gain more peer support in pre or post operative.

Robotic Hernia (Abdominal Wall Reconstruction)

We are consolidating new results of evidence tables and will see if we need more panel discussion. Outcomes will determine if changes will be needed.

Gastroparesis (Expert Review)

This project was initially very broad. We have paired it down and it is now a more indepth introduction. Rome came out recently with some useful advice. Reviewing data tomorrow. Expert consensus on data will be next.

Endoscopy Privileging/Credentialing

Initial literature search was outdated, so a new literature search was made by Holly Burt (Librarian). New trainees will be begin abstract and title screening.

Ergonomics Guideline

This is a new project, it's going well. PICO meeting done, literature search done, trainees have started on work, panel discussion will begin in July. Ergonomics task force is also collaborating with us on this project.

Treatment Techniques for Necrotizing Pancreatitis

Kevin El-Hayek

This is a new project, in collaboration with AHPBA. Abstract review with trainees has been completed, moving forward with extraction. We also have had input from radiology, 3 patient partners and gastrology.

Laparoscopic Resection of Colon and Rectal Disease (upcoming)

No update was given on this.

Once more guidelines have been completed we can start to add more to our working guidelines.

Once we have decided on new topics we will send an email to all members to see who would like to join and who has expertise in the specific topic.

Dr. Slater mentioned that there may be a collaboration with EAES where some members can go to learn more about how they approach the guideline process.
